Award for Muslim and non-Muslim Understanding

Selection Criteria

In choosing the Award for Muslim and non-Muslim Understanding, regard is given to the nominee's recent achievements prior to receiving the award as well as their consistent achievements (the past 1 to 5 years) and ongoing contribution to the Australian community and nation. Both individuals and organisations are eligible.

The Award will also consider the potential of the person or organisation to achieve in the future and the platform that this Award will provide for them.

No weight is given to the number of times an individual or organisation is nominated.

Individual

- Significant contribution in improving relations between Muslim and non-Muslim people
- An inspirational role model for the Australian and wider community
- Scope of the impact this person has had on creating understanding between Muslims and non-Muslims

Organisation

- Demonstrated contribution by the organisation to the Australian community in improving relations between Muslim and non-Muslim people
- The organisation is a leader in best practice for Muslim and non-Muslim understanding
- Scope of the impact this organisation has had on the understanding between Muslim and non-Muslim people in Australia
- Organisations nominated must have evidence of being sustainable in the future

Eligibility Criteria

Individual


- Nominees must be an Australian citizen or permanent resident in Australia of any or no religious affiliation
- Awards will not be granted posthumously
- Self-nominations or nominations by immediate family will not be accepted
- Nominees must be at least 18 years of age on
 1 January 2012
- Sitting state and federal politicians and current vice-regal officers are not eligible
- Retired politicians and vice-regal officers will be considered for work undertaken in addition to their official duties
- Current staff and board members of the Australia Day Council of SA will not be eligible
- Current staff, adjunct staff and council members of the University of South Australia will not be eligible

Organisation

- Nominees must be an organisation based and active in Australia
- · Self-nominations will not be accepted
- Innovative individual projects and programs of government departments and statutory authorities will be considered
