The efforts of the MCF has been recognized by the Logan City Council and we were nominated for a community award .I am proud to advise that the MCF won the Award in the category of Non Profit Organizations at the Multicultural Business and Community Awards. Janeth Deen won the Volunteer of the Year Award at the same function.

Globally the crisis in the Muslim world continues unabated and we have been actively supporting and assisting in collections for Syria, Palestine, Somalia, Fiji and Burma.

Locally we are experiencing an increase in requests for assistance and support and our Monthly Case Report bears testimony to this fact.

On reflection we have done exceptionally well, however there is always room for improvement and we need to focus on the following;

- MCF needs increase awareness amongst all stakeholders including potential recipients and donors.
- MCF needs to develop a stronger culture and base of volunteers
- MCF needs to expand nationally to ensure a wider remit.
- MCF needs to improve the process of collection and distribution of aid.
- MCF needs to promote the principles and obligations of Zakat incumbent on all Muslims

With respect to the future I see our role as follows;

- Continue in delivering and meeting our objectives and developing best practices and improved processes.
- Collaborating and actively engaging the Imams and Trust Boards of Masajid.
- To become the role model amongst our peers and the organization of choice of all stakeholders.
- Develop field operations and ensure delivery of the services and funds actively.
- To export the current model to all states within Australia.

Finally I wish to record my sincere gratitude to those who have contributed to the MCF be it in respect of your valuable time, funds and expertise to meet our aims and objectives and most of all in placing your trust in the organization.
