

DIAL A HOME DOCTOR PTY LTD GIVEAWAY – TERMS AND CONDITIONS OF ENTRY

STANDARD TERMS

1. Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER

2.1. Subject to clause 2, entry is open to all Queensland, Australia residents aged 18 years or older.

2.2. Employees, franchisees or contractors and their immediate families of the Dial A Home Doctor Group of Companies or related agencies are not eligible to enter. Immediate family means any of the following: spouse, de-facto spouse, child or step-child (whether by natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, or step-sister.

2.3. Persons under the age of 16 must be accompanied by an adult over the age of 18.

3. HOW TO ENTER

The giveaway period commences on 8th September 2017 17:00pm (AEST)

3.1 Entries for the event on 11th November will close on 29th October 23:59 (AESTD) and the draw for the event will be held under supervision on 30th October 2017 10:00 (AEST). (“the Competition Period”).
